



IM-Series Potable Water Tank Assembly Checklist & Assembler Authorization

Please read each line of the following checklist items carefully and initial each line to confirm that you both understand and will perform the required tasks for each Infiltrator Water Technologies IM-Series Potable Water Tank (IM-550C, IM-1280C and IM-1760C) that you assemble.

Assembly Checklist: Tank Authorized: IM-550C IM-1280C IM-1760C

_____ I have access to the proper equipment to off-load the tank pallet [A forklift with 66" minimum fork length (extensions are acceptable) and minimum 10' pick height. Minimum forklift capacities vary by tank.] from the flatbed truck with pallet forks.
_____ I understand that the lifting straps provided in the starter kit can be used to lift no more than 2 IM-1760C tank halves, 4 IM-1280C tank halves or 8 IM-550C tank halves at one time.

- Inspect the tank pallet and/or starter kit and confirm that all components/materials are present (see materials list) and in good condition.
- Lift bottom half of tank and place in assembly area.
- Verify that the gasket is properly seated in the lower tank half groove and use a coarse-bristled paint brush or clean rags to remove any dirt or debris from the gasket.
- Insert all dowel/alignment pins on bottom tank half.
- Make sure baffle wall indexing groove matches the indexing ribs on the tank and is properly oriented.
- Apply an even coat of NSF 61 certified lubricant to exposed gasket.
- Lift top half of tank and align with dowel/alignment pins.
- Carefully lower top half of tank onto bottom half and visually verify that the gasket is properly seated in each tank half.
- Install two locking clips in each of the four corners of tank and rotate tank 45 degrees to provide access into openings in tank upper half.
- Insert a fiberglass support post into each molded post seat, as applicable.
- Install the remaining locking clips working your way around the perimeter of the tank.
- Install the appropriate risers and lids per site specifications.

 _____ I agree not to sell any unassembled (two shells) tanks to any person or company unable to show proof verifying their authorization by Infiltrator to assemble IM-Series Potable Water Tanks (every tank serial # will be linked to the authorized distributor where the tank was delivered).
 _____ I agree that IM-Series Potable Water Tanks will only be assembled by employees of my organization who are under responsible charge of an individual who has been trained by Infiltrator Water Technologies.

Assembler Authorization:

Your initials on the lines above and signature below confirm that you understand each step in the process of assembling an IM-Series Potable Water Tank. Infiltrator gives you the authority to assemble and deliver assembled tanks. Infiltrator Water Technologies will extend additionally insured coverage to authorized IM-Series Potable Water Tank assembly partners that agree to the terms on the Assembly Checklist above in accordance with the following:

- Coverage will be extended only when this signed checklist is returned to Infiltrator Water Technologies corporate headquarters in Old Saybrook, CT.
- Authorized IM-Series Potable Water Tank assembly partners will receive an insurance certificate from our insurance provider. If you do not receive a certificate in a timely manner, please follow up with your local sales representative.
- As an authorized IM-Series Potable Water Tank assembler, Infiltrator's general liability policy extends additional insured coverage to you by way of a vendor's liability endorsement. This means that you will have coverage under Infiltrator's policy for bodily injury or property damage arising out of Infiltrator IM-Series Potable Water Tanks that you assemble, distribute or sell. The coverage afforded to you is subject to the terms and conditions of the policy. A good example of an action that would invalidate your additional insured status would be your failure to follow the above Assembly Checklist and IM-Series Potable Water Tank Assembly Instructions.
- Additionally insured coverage does not provide replacement coverage for the actual product (i.e. property damage resulting from a failed tank will be covered). The tank itself will be covered under the terms of the Infiltrator Potable Water Tank Limited Warranty.

**INFILTRATOR WATER TECHNOLOGIES (“INFILTRATOR”) INFILTRATOR® POTABLE WATER TANK LIMITED WARRANTY
FIVE (5) YEAR MATERIALS AND WORKMANSHIP LIMITED WARRANTY**

- (a) This limited warranty is extended to the end user of an Infiltrator Potable Water Tank. A Potable Water Tank manufactured by Infiltrator, when installed and operated in accordance with Infiltrator’s installation instructions and local regulation by a licensed installer, is warranted to you: (i) against defective materials and workmanship for five (5) years after installation. Infiltrator will, at its option, (i) repair the defective product or (ii) replace the defective materials. Infiltrator’s liability specifically excludes the cost of removal and/or installation of the Potable Water Tank.
- (b) In order to exercise its warranty rights, you must notify Infiltrator in writing at its corporate headquarters in Old Saybrook, Connecticut within fifteen (15) days of the alleged defect.
- (c) YOUR EXCLUSIVE REMEDY WITH RESPECT TO ANY AND ALL LOSSES OR DAMAGES RESULTING FROM ANY CAUSE WHATSOEVER SHALL BE SPECIFIED IN SUBPARAGRAPH (a) ABOVE. INFILTRATOR SHALL IN NO EVENT BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, HOWEVER OCCASIONED, WHETHER BY NEGLIGENCE OR OTHERWISE. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THIS LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.
- (d) THIS LIMITED WARRANTY IS THE EXCLUSIVE WARRANTY GIVEN BY INFILTRATOR AND SUPERSEDES ANY PRIOR, CONTRARY, ADDITIONAL, OR SUBSEQUENT REPRESENTATIONS, WHETHER ORAL OR WRITTEN. INFILTRATOR DISCLAIMS AND EXCLUDES TO THE GREATEST EXTENT ALLOWED BY LAW ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTY OF MERCHANTABILITY, FINESSE FOR A PARTICULAR PURPOSE AND ANY IMPLIED WARRANTIES OTHERWISE ARISING FROM COURSE OF DEALING, COURSE OF PERFORMANCE, OR USAGE OF TRADE. NO PERSON (INCLUDING ANY EMPLOYEE, AGENT, DEALER, OR REPRESENTATIVE) IS AUTHORIZED TO MAKE ANY REPRESENTATION OR WARRANTY CONCERNING THIS PRODUCT, EXCEPT TO REFER YOU TO THIS LIMITED WARRANTY. EXCEPT AS EXPRESSLY SET FORTH HEREIN, THIS WARRANTY IS NOT A WARRANTY OF FUTURE PERFORMANCE, BUT ONLY A WARRANTY TO REPAIR OR REPLACE.
- (e) YOU MAY ASSIGN THIS LIMITED WARRANTY TO A SUBSEQUENT PURCHASER OF YOUR HOME.
- (f) NO REPRESENTATIVE OF INFILTRATOR HAS THE AUTHORITY TO CHANGE THIS LIMITED WARRANTY IN ANY MANNER WHATSOEVER, OR TO EXTEND THIS LIMITED WARRANTY.

CONDITIONS AND EXCLUSIONS

There are certain conditions or applications over which Infiltrator has no control. Defects or problems as a result of such conditions or applications are not the responsibility of Infiltrator and are NOT covered under this warranty. They include failure to install the Potable Water Tank in accordance with instructions or applicable regulatory requirements or guidance, altering the Potable Water Tank contrary to the installation instructions and disposing of chemicals or other materials contrary to normal Potable Water Tank usage.

The above represents the Standard Limited Warranty offered by Infiltrator. A limited number of states and counties have different warranty requirements. Any purchaser of a Potable Water Tank should contact Infiltrator’s corporate headquarters in Old Saybrook, Connecticut, prior to such purchase to obtain a copy of the applicable warranty, and should carefully read that warranty prior to the purchase of a Potable Water Tank.

IM-SERIES POTABLE WATER TANK LIMITED LIABILITY

The IM-Series Potable Water Tank is NSF/ANSI 61 certified. NSF/ANSI 61 establishes minimum health effects requirements for materials, components, products or systems that contact drinking water, drinking water treatment chemical, or both. This includes minimum health effects requirements for the chemical contaminants and impurities that are indirectly imparted to drinking water from products, components, and materials used in drinking water systems. NSF/ANSI 61 does not establish performance, taste and odor, or microbial growth support requirements for drinking water system products, components, or materials. The tank purchaser is solely responsible for ensuring that provisions are in place to meet applicable local, state, and federal water quality standards for a drinking water system that includes an IM-Series Potable Water Tank. Potable water systems that incorporate the IM-Series Potable Water Tank must be designed and installed by properly licensed professionals and regular water quality testing should be conducted for the system in accordance with applicable requirements. In addition, care should be taken to have the IM-Series Potable Water Tank thoroughly cleaned and disinfected prior to use and as necessary to maintain acceptable water quality during its service life. Infiltrator Water Technologies is not responsible for water quality produced by drinking water systems containing the IM-Series Potable Water Tank.
